NOTICE INVITING TENDER

- 1. Online item-rate e-tenders are hereby invited through e-tendering portal https://etenders.gov.in/eprocure/app for the work of "Replacement of old street light pole with new street light pole, cabling and feeder pillar work on internal road in office and guest house campus at CSIR-HRDC Ghaziabad" from contractors of appropriate class of CPWD, Railways, MES, Post & Telegraph Deptt., State PWD's, Semi Government Organizations and / or from those who have successfully carried out similar works for CSIR or its laboratories, Govt. & Semi Government Organizations. The tenderers should have successfully completed at least three similar works amounting to Rs. 16.46 Lakhs or at least two similar works amounting to Rs.24.69 Lakhs or at least one work amounting to Rs. 32.92 Lakhs or above in a single contract during the last seven years, ending on the last day on the month previous to the one in which tender is being invited. The contractors may apply with proof of fulfilling the above conditions along with copies of PAN Card, GST registration number, satisfactory work completion certificates and valid electrical license.
- The Estimated cost of work is Rs. 41,14,486.00 (Rupees Forty one lakh fourteen thousand four hundred eighty six only) based on CPWD, DSR-2016, prevailing market rates including labour cess & GST.
- 3. Duration of contract for carrying out of the work will be **120 Days** from the date of commencement which shall be reckoned from the tenth day of issue of award letter.
- 4. The tender in two bid system shall be submitted through online at CPP-portal website https://etenders.gov.in/eprocure/app by the tenderer, as per date given in Critical Date Sheet below:

5. Tender processing fee of Rs. 500/- (Rupees five hundred only) non-refundable and Earnest Money Deposit (EMD) of Rs. 82,500/- (Rupees sixty two thousand five hundred only) will required to be paid offline in the form of Demand Draft (DD) drawn in favour of HRDC, GHAZIABAD payable at Ghaziabad from nationalized or any scheduled bank (but not from co-operative or Gramin Bank). Those tenderers, who are exempted from the payment

of Earnest Money and Tender Cost, shall upload the scanned copy of valid exemption certificate. The original demand Drafts (DD) / self-attested copy of valid exemption certificate, against above should reach by post / courier / given in person to Executive Engineer, CSIR-Human Resource Development Centre, Sector-19, Central Govt. Enclave, Kamla Nehru Nagar, Ghaziabad-201002 as specified in the critical data sheet given in subsequent para of this e-NIT. The details of Demand Drafts / exemption certificate, physically sent, should tally with the details available in the scanned copy and the data entered during bid submission time in cover-I.

The tenderers who fail to submit the hard copy of Tender fee & EMD (in original) / exemption certificate by due date and time, their tender shall be rejected out-rightly. Postal delay, if any, will not be considered / entertained.

- 6. Scanned copies of Tender processing fee and Earnest Money Deposit (EMD) shall be uploaded in Cover-I of the e-tender. Tenders received without tender cost and earnest money deposit will not be considered.
- 7. The employer does not bind himself to accept the lowest or any tender and reserves to himself the right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at the rates quoted by him.
- 8. The tenderer shall not be permitted to tender for works in the concerned unit of C.S.I.R. in which a relative is posted in the grade between Controller of Administration and Junior Engineer, (both inclusive). He shall also intimate the name of persons who are working with him in any capacity or subsequently employed by him and who relatives are as mentioned above.

Note: A person shall be deemed to be a relative of another if, and only if, (a) they are members of a Hindu undivided family or (b) they are husband and wife or (c) the one is related to the other in the following manner: father, mother (including step mother), son (including step son), Son's wife, Daughter (including step daughter), Father's father, Son's son, Son's son's wife, Son's daughter, Son's daughter's husband, Daughter's husband, Daughter's son, Daughter's son's wife, Daughter's daughter, Daughter's daughter's husband, Brother (including step brother), Brother's wife, Sister (including step sister), Sister's husband.

- 9. Tenders submitted shall remain valid for a period of 90 days from the bid submission end date for the purpose of acceptance and award of work. Validity of the tender beyond 90 days from the bid submission end date shall be extended by mutual consent.
- 10. In e-tendering, tenderer can quote the rates in figure only. The rates in words, amount of each item and total is generated automatically. Therefore, the rate quoted by the tenderer in figure is to be taken as correct.
- 11. The tenderer should carefully see the contract drawings (as applicable) as no claim whatsoever will be entertained for any alleged ignorance thereof.
- 12. Before tendering, the tenderer shall inspect the site to fully acquaint himself about the conditions in regard to accessibility of site, nature and area/extent of ground, working conditions of site and locality including stacking of materials, installations of tools & plants etc., conditions affecting accommodations and movement of labour etc. required for the satisfactory execution of contract. No claim whatsoever on such accounts shall be entertained by the Employer under any circumstances.

- 13. If any tenderer withdraws his tender within the validity period or makes any modification in terms and conditions of the tender, before the award of work, which are not acceptable to CSIR-HRDC then CSIR-HRDC shall, without prejudice to any other right or remedy, shall be at the liberty to forfeit 50 % (fifty percent) of the Earnest Money deposit absolutely. Further, the tenderer shall not be allowed to participate in the re-tendering process for this work.
- 14. 100% Earnest Money will be forfeited if the contractor fails to commence the work within the stipulated period after the Award of the work.
- 15. Except writing rates in figure only, the tenderer should not write any conditions or make any changes, additions, alterations and modifications.
- 16. Some of the major provisions of General Conditions of Contract are given below. Interpretations, however, shall be as given in the General Conditions of Contract.
 - a. **DEFECTS LIABILITY PERIOD** is of 12 Months from the date of completion as certified by the Engineer-In-Charge.
 - b. Minimum value of work for the intermediate / interim certificate will be Rs.5.00 Lakh. However, a lesser amount can be admitted for intermediate / interim certificate at the discretion of the Engineer-In-Charge.
 - c. **SECURITY DEPOSIT**: A sum @ 10 % of the gross amount of the bill shall be deducted from each running bill of the contractor till the sum along with sum already deposited as earnest money, amounts to 5 % of the tendered value of the work. In addition, the contractor shall be required to deposit an amount equal to 5 % of the contract value as performance security within the period prescribed in the letter of award issued to him.
 - d. COMPENSATION: Contractor shall pay, as compensation, an amount equal to one percent or such smaller amount as Employer (whose decision in writing shall be final) may decide on the cost of whole work as shown in the agreement, for every week that the work remains un-commenced or unfinished or due quantity of work remains incomplete after the scheduled dates. Compensation to be paid shall not exceed ten percent of the contract amount as shown in the agreement.
- 17. For any queries relating to the Tender Document and the terms and conditions content therein should be addressed to Executive Engineer, CSIR-HRDC, Sector- 19, Central Govt. Enclave, Kamla Nehru Nagar, Ghaziabad-201002 [Tel.: 0120-2785792].
- 18. Clauses No. 28 of General Conditions of Contract i.e. **"ESCALATION"** will not be applicable in this work.
- 19. Goods and Service Tax (GST) will be applicable their bill as per standard norms of the Government. The contractor shall quote their rates inclusive of all taxes i.e. GST & Labourcess etc.
- 20. The tenderer is to indicate the name and telephone nos. of issuing agency of the completion certificate to enable the verification of the document, if necessary. It may be noted that even after opening of price bid, the credential submitted found to be false / forged the offer

submitted shall be rejected out rightly. No further clarification will be sought from the tenderers.

- 21. Electrical License: The contractor shall have to submit the valid electrical license during applying of tender, issued from the Competent Authority in the name of the firm / contractor (under renewal application of electrical license will be not applicable) and also they shall have to possess electrical license issued by any state Govt. under clause 45 of compilation of rule of Indian electricity rules 1956 or as amended from time to time. If the work is awarded to the contractor having license of some other state. The contractor shall have to submit the electrical license of the state Authority where the tender has been applied within three months from award of the work. After award of work contractor shall keep valid license throughout the period of contract by getting it renewed at suitable intervals and submit an attested copy of the same to the department. In the event of any discontinuity invalidity of electrical license of the contractor, its contract is liable for termination.
- 22. **Similar work:** Similar works means installation of street light poles including cabling and exterior work etc.

23. Opening of Technical Bid (Cover. I)

- (a) The Technical bid will be opened by Tender Opening Committee (TOC) on 24.12.2018 at 03.00 PM, in the office of Administration, CSIR-HRDC, Sector 19, Central Govt, Enclave, Kamla Nehru Nagar, Ghaziabad-201002 in the presence of such intending tenderers or their authorized representatives who may wish to be present at that time. No claim or any grievances will be entertained what-so-ever by the Tender Opening Committee in this regard.
- (b) The TEC, after evaluation of documents contained in Cover-I i.e. Technical Bid, will decide the eligible tenders, as per the criteria laid down in the NIT.
- (c) The TOC will then open the Financial Bids of only eligible tenderer.

24. Opening of Financial Bid (Cover- II)

The Cover-II of Eligible Tenderers shall be opened serially. The total amount quoted by the tenderers shall then be read out by the TOC for information of those present / participated.

25. Tender Liable for Rejection.

Tender is liable for outright rejection if on opening it is found that:

- (a) The Tenderer has not strictly followed the procedure laid down for submission of tender.
- (b) If the tender is CONDITIONAL.
- (c) If the Tenderer has quoted his offer anywhere else other than specified place provided.
- (d) The Tenderer has not uploaded the documents or Failed to fill the prescribed format.
- (e) Any other ground as decided by the TEC in view of deviation from Tender Document.
- 26. The instructions for the submission of e-tender are available on the CPP portal i.e. https://etenders.gov.in/eprocure/app under the "Instruction for Online Bid Submission". All

- the intending tenderers are requested to go through these instructions before entering into the process of e-tendering.
- 27. The tenderer shall submit a **Tender acceptance letter as per Annexure-A** on the form letter head. The scanned copy of the undertaking shall be uploaded in Cover-I and the Original copy of the undertaking should be submitted before award of work to Engineering Services Unit.
- 28. Head, CSIR-HRDC reserves the right to reject any or all the tender in part or full without assigning any reason (s).
